As a focal point of the International Climate Initiative (IKI) of the German Government, the Ministry of Environment and Natural Resources in the Dominican Republic hereby expresses its intent to support The Nature Conservancy and the countries involved in the project entitled: Pioneering a Strategic Approach for Conserving and Restoring Caribbean Coral Reef Ecosystems Targeted at Climate Resilient Refuges ("CoralCarib").

We understand that the project should include activities in five countries: Belize, Cuba, Haiti, Jamaica and the Dominican Republic. - d. Work Package IV (Policy proposal and resource mobilization): For example: Coordinate partners in regional coral reef action plans, policy framework assessments as well as knowledge sharing at the regional and global levels.

In this regard, we hereby express our support for the CoralCarib project and our commitment to attend the scheduled project coordination and planning meetings in order to guarantee effective collaboration.
